The parent gives his/her child permission to participate in all Coniston activities and programs whether those take place on or off Coniston property. - Deposits & Cancellations – An initial deposit of \$200 is due with this application. Half of the deposit will be refunded if cancellations are received before January 1. The entire deposit is non refundable and non transferable after January 1.
- Final payments are due by May 1st. Refunds are considered only with medical documentation. Accounts unpaid on May 1st will be assessed a \$50 late fee and will be subject to cancellation.
